

SUBSEQUENT HISTORIES TABLE

This table contains subsequent histories, if any, of all ALRB decisions through Volume 48 (2022).

METHOD

This table reflects only those Board decisions which have been reviewed or cited by reviewing courts, or later modified, overruled or clarified by the Board. Beneath the designation of each such case in the table is a listing which indicates the history of the case and the treatment of the case.

If a Board decision is later modified and both the initial decision and the modification were treated by the reviewing court, the treatment of the case will be found under the designation for the modified opinion. The earlier decision will also be given, but the history of that decision will stop at the point of the modification; the modified opinion will be given and indicated by the code "M."
