The General Counsel issued the subpoenas to Berenda Ranch LLC, Christopher G. Lagorio Trusts, Delta Pre-Pack Co., Kathleen Lagorio Janssen Trust, K.L.J. LLC, Janssen Living Trust, Lagorio Farming Co., Inc., Lagorio Farms, LLC Lagorio Leasing Co. and Lagorio Properties, LP¹ on January 10, 2013, requesting the production of documents by January 24, 2013. The General Counsel represents that she has attempted to meet and confer with the additional Respondents above on January 30 and 31, 2013; however, as of the filing of the current request by the General Counsel, Respondents have failed to respond to the subpoenas.
