On August 25, 2017, the General Counsel of the Agricultural Labor Relations Board ("ALRB" or "Board") filed with the Board a request for leave to seek judicial enforcement of the Board's decision and order in the above-captioned case, *California Artichoke and Vegetable Corporation dba Ocean Mist Farms* (2015) 41 ALRB No. 2, and a supporting declaration. The request for enforcement alleges that, despite repeated requests, respondent California Artichoke and Vegetable Corporation dba Ocean Mist Farms ("Respondent") has failed to voluntarily comply with the Board's order. Pursuant to the Board's Administrative Order No. 2017-11, issued on September 13, 2017,

Respondent on September 20 submitted a declaration by its attorney in response to the General Counsel's enforcement request.

On October 4, 2017, the Regional Director of the Salinas Regional Office submitted to the Board for approval a [Proposed] Bilateral, Formal and Partial Settlement Agreement ("Agreement") between Respondent, charging party Jaime Boyzo Araujo, and the Salinas Regional Director. The Agreement resolves the final outstanding backpay dispute with respect to charging party Jaime Boyzo Araujo. Paragraph 13 of the Agreement additionally represents that "Respondent and the Regional Director agree to make immediate efforts to complete effectuation of the Board Order 41 ALRB 2 (2015). Therefore, the Salinas Regional Director will move to stay her Motion for Court Enforcement of Board Order 41 ALRB 2 (2015) for 30 days so the parties may execute the remaining terms of the Board Order – mailing, noticing and posting."

The Regional Director filed such a motion to stay on October 9. Finding good cause exists to support the motion, the Board hereby GRANTS the Regional Director's motion for a 30-day stay of its request to seek judicial enforcement of the Board's order in 41 ALRB No. 2. The Board further orders both the Regional Director and Respondent
