OPEN SESSION

1. Approval of Minutes: The Board minutes for November 7, 2007 were approved 3-0.

2. Public Comments: None.

- **3.** Chair Budget Report Accounting Officer Davis reported on the status of the current budget.
- **4. General Counsel Report**: General Counsel Lee reported that 20 charges have been filed since the last meeting in the Salinas and Visalia Regional Offices. An election will be held this Friday, December 14, at Mayflower Companies et al., a dairy located in Pixley. All regional offices will be participating in the election.

ELECTION REPORT:

PENDING ELECTION MATTERS:

Jim Nace Dairy, 07-RD-3-VI

On May 25, 2007 agricultural employee Raul Camarena Lopez filed a decertification petition with the Visalia Regional Office seeking to decertify the incumbent union,

UFCW Local 5, at Jim Nace Dairy. The employer operates a dairy in Tipton, CA with approximately 18 employees. The election was held on June 1, 2007 with the following results:

On June 7, 2007 UFCW filed objections to the election. On June 15, the Acting Executive Secretary issued an order setting two objections for hearing and dismissing the remaining objection. Any request for review of the partial dismissal was due June 25, 2007. No request for review was filed. The hearing on objections was held on August 20, 2007. The IHE's decision issued October 31, 2007. Exceptions were due November 13, 2007. No exceptions were filed. On November 15, 2007 the Executive Secretary issued an order making the IHE decision final and certifying the results of the election. This case will now be removed from this report.

Gallo Vineyards, Inc., 07-RD-1-SAL

On June 18, Roberto Parra filed a decertification petition seeking to remove the United Farm Workers of America as the exclusive bargaining representative of Gallo's agricultural employees in Sonoma County. The petition lists the approximate number of employees in the unit as 400. The election was held on June 25, 2007 and yielded the following results:

On July 2, 2007 the UFW filed objections to the election. The objections will be held in abeyance pending resolution of ulps mirroring the election objections. On October 5, 2007 the Regional Director dismissed three overlapping charges (07-CE-23-SAL, 07-CE-25-SAL and 07-CE-26-SAL). One charge is still under investigation (07-CE-24-SAL). On October 18, 2007 the UFW filed a request for review of three of the four charges. On November 16, 2008 the General Counsel affirmed the Regional Director's dismissal of the three charges. The matter is pending resolution of the remaining charge and screening of the union's objections.

Richard's Grove & Saralee's Vineyard, Inc., 07-RD-2-SAL

On July 19, 2007 agricultural employee Victorino Velasquez filed a decertification petition with the Salinas Regional Office seeking an election to oust the incumbent collective bargaining representative, the United Farm Workers. Richard's Grove & Saralee's Vineyard, Inc. is a vineyard located in Windsor that is engaged in the

growing of wine grapes. The petition seeks a bargaining unit consisting of all the agricultural employees in the State of California. An election was held July 26, 2007 with the following results:

The no union choice received a majority vote so the unresolved challenged ballots were not resolved as they were not outcome determinative. On August 2, 2007 the UFW filed objections to the election. The objections will be held in abeyance pending resolution of an ulp charge that mirrors the allegations in the election objection. On October 4, 2007 the Regional Director dismissed the overlapping charge (07-CE-27-SAL). The request for review was due on October 17, 2007 and none was filed. On October 23, 2007 the Executive Secretary issued his order dismissing the UFW's sole objection. On November 1, 2007 the UFW filed its request for review. The matter has been transferred to the Board and is pending decision.

Lassen Dairy dba Meritage Dairy, 07-RC-4-VI

On September 4, 2007 UFCW International Union, Local 5 filed a representation petition with the Visalia Regional Office seeking to represent the agricultural employees of Lassen Dairy dba Meritage Dairy. The employer is a dairy located in Bakersfield with approximately 25 employees. An election was held on September 11, 2007 with the following results:

As the unresolved challenged ballots were outcome determinative, the Regional Director investigated the challenges and issued his report on challenged ballots on November 9, 2007. The Employer filed exceptions to that report on November 19, 2007. The matter is now before the Board for decision. The Employer also filed objections to the election on September 18, 2007 that are pending before the Executive Secretary for decision.

Boschma & Sons Dairy, 07-RC-5-VI

On November 9, 2007 UFCW International Union, Local 5 filed a representation petition with the Visalia Regional Office seeking to represent the agricultural employees of Boschma & Sons Dairy. The employer is a dairy located in Wasco with 21 employees. An election was held on November 16, 2007 with the following results:

On November 26, 2007 the Employer filed its objections to the election. The matter is pending before the Executive Secretary for decision.

Frank Silva Dairy, 07-RC-6-VI

On September 4, 2007 UFCW International Union, Local 5 filed a representation petition with the Visalia Regional Office seeking to represent the agricultural employees of Frank Silva Dairy. The employer is a dairy located in Ceres with 4 employees. An election was held on November 16, 2007 with the following results:

Election objections were due November 26, 2007. No objections were filed. On November 30, 2007 the Executive Secretary issued a certification of representative. This matter is now fully resolved and will be eliminated from this report.

Mayflower Companies et al., 07-RC-7-VI

On December 7, 2007 UFCW International Union, Local 5 filed a representation petition with the Visalia Regional Office seeking to represent the agricultural employees of Mayflower Companies et al. The employer is a dairy located in Pixley with approximately 31 employees. The election will be held on Friday, December 14, 2007. Given the size of the unit, no outside assistance is necessary at this time.

Rocking S. Dairies, 07-UC-01-VI

UFCW Local 5 filed a unit clarification petition seeking to clarify the bargaining unit designated in its certification of July 23, 2007 to now include the employees of The Oaks Ranch. The union alleges that The Oaks Ranch is a single employer with Rocking S. Dairies. The matter is under investigation by the Visalia Regional Director and is pending a report on the unit clarification.
