ⁱ *Requirements for Entry to Building with Federal Agencies as Tenants

The Agricultural Labor Relations Board is a tenant in a building shared with several federal agencies. As such, the building is governed by federal security regulations found at Title 41, Code of Federal Regulations, Part 102-74, Subpart C. These regulations provide that federal agencies may inspect, at their discretion, backpacks, briefcases, purses or other containers in the immediate possession of visitors entering or departing federal property. Visitors to the ALRB may have these items subject to inspection and should be prepared to show a valid photo ID. Items prohibited on federal property include guns, flammable or explosive materials, sharp objects, tools, club-like items, and disabling chemicals. The Board will have ALRB staff present at the security desk to assist ALRB visitors with gaining entrance to the building on Board meeting days.
