On March 25, 2020, charging party United Farm Workers of America (UFW) and respondent Premiere Raspberries, LLC (Premiere) filed a joint request for an extension of time to comply with the order of the Agricultural Labor Relations Board (ALRB or Board) in *Premiere Raspberries*, *LLC* (Mar. 24, 2020) ALRB Admin. Order No. 2020-06. The parties represent they need to reduce their settlement agreement to writing, the UFW's counsel has been out of the country, and further that the current circumstances presented by the coronavirus shelter-at-home orders have contributed to delay in finalizing the agreement. The parties further represent the Salinas regional office is agreeable to the requested extensions of time.

Salinas Regional Director a copy of their settlement agreement by Thursday, April 2,

2020. It is further ORDERED that the Salinas Regional Director's statement pursuant

to our Administrative Order No. 2020-06 shall be submitted to the Board no later than

Friday, April 10, 2020.
