On March 6, 2020, the Agricultural Labor Relations Board (ALRB or Board) issued *Premiere Raspberries, LLC* (Mar. 6, 2020) ALRB Admin. Order No. 2020-04. On March 13, the United Farm Workers of America (UFW) filed a request for an extension of time to file a motion for reconsideration. The Executive Secretary granted the request.

Per the granted extension of time, the UFW filed its motion for reconsideration on March 27. The UFW seeks reconsideration of the Board's order on two grounds. First, the UFW contends its request the Board commence a superior court action to enforce the mandatory mediation and conciliation (MMC) contract is not time-barred under Labor Code section 1164.3, subdivision (f). (See *Premiere Raspberries*, *LLC*, *supra*, ALRB Admin. Order No. 2020-04, pp. 7-9.) Second, the UFW asserts its request for referral to supplemental MMC proceedings is not time-barred under Labor

Code section 1164.10, subdivision (b). (See *id*. at p. 11.)

Two weeks before the UFW filed its motion, Premiere filed a motion for reconsideration of our order in *Premiere Raspberries*, *LLC* (Mar. 6, 2020) ALRB Admin. Order No. 2020-05-P, representing that the parties had reached a settlement covering both this matter and the unfair labor practice proceeding (case no. 2018-CE-004-SAL). On March 24, the Board issued its order in *Premiere Raspberries*, *LLC* (Mar. 24, 2020) ALRB Admin. Order No. 2020-06, directing the parties to submit their purported settlement to the Salinas Regional Director for approval. On March 25, two days before the UFW filed its motion, the UFW and Premiere filed a joint request for an extension of time to comply with the Board's Administrative Order No. 2020-06 to provide additional time to reduce their agreement to writing and submit it to the Regional Director.

<u>ORDER</u>

The Board hereby GRANTS Premiere an opportunity to respond to the UFW's motion for reconsideration in this case. Any such response must be received by the Board no later than Wednesday, April 15, 2020.
