The Regional Director of the Salinas Region of the Agricultural Labor Relations Board (ALRB or Board) has filed with the Board a statement in support of a proposed formal bilateral settlement agreement (Statement in Support) and accompanying declaration of Michael I. Marsh (Marsh Declaration). The Statement in Support states the makewhole liability of Premiere Raspberries, LLC (Premiere) for the period August 28, 2018, to the present to be approximately \$9,145,099. However, the Marsh Declaration states that the liability for this period is "nine million one hundred and forty-five thousand and ninety-nine dollars (\$1,145,099)." (Emphasis added.) The Board requires clarification concerning which of the two stated amounts is the correct amount for this period.

ORDER

The Salinas Regional Director is hereby ORDERED to file a response stating which of the two figures stated in the Statement in Support and Marsh Declaration is the correct amount for the period August 28, 2018, to the present. The Regional Director's response must be received by the Board by close of business on Friday, December 4, 2020. ¹
