Report of Salinas Office

Presented by Franchesca Herrera, Salinas Regional Director Update since last Regional Directors Meeting, June 23, 2020

- 7 informal settlements.
- 44 Charges against Employers (CE) so far this year.
- 4 Charges against Labor (CL) so far this year.
- Only one charge specifically about lack of Covid-19 safety measures.
- Three other charges where Covid-19 was one of several factors in the charge.
- Oxnard and Salinas offices are open daily 8:00 A.M. to 5:00 P.M., often until 7:00 P.M.
- Santa Rosa office is still not open.
- Reports that some farmworkers in Monterey and Sonoma Counties were ordered to work in wildfire evacuation zones.
- Several outreach events were cancelled due to Covid-19 and wildfires.
- No new Notices to Take Access (NA).
- No new Notices to Organize (NO).
- No new election petitions.

Report of Visalia Office

Presented by Chris Schneider, Visalia Regional Director. Update since last Regional Directors Meeting, June 23, 2020.

- No evacuations of staff.
- 38 checks were distributed.
- 70 more checks will be distributed this Saturday.
- One union backed-out of holding an election.
- Settlement agreement, after Yergat stated in writing that harvesters were fired for complaining about a new work process. Hearing will be taken off calendar.
- Chris Schneider is working with Centro Binacional para el Desarollo Indígena Oaxaqueño (CBDIO) to distribute leaflets and masks.

Comments

Franchesca Herrera:

- GC should repeat prior training about indigenous cultures, for new staff and for anyone in contact with farmworkers on outreach.
- Avoiding cultural misunderstandings, such as averting eye contact in Mixteco culture (sign of respect) versus American culture (lack of credibility).

Ralph Lightstone and Barry Broad:

• ALJs should also attend the indigenous cultures training.

Itir Yakir:

• Farmworkers and employers should also be trained about cultural discrimination.

Franchesca Herrera:

- Reading remedies should be in English, Spanish, Mixteco, and possibly Zapoteco.
- Follow the example set by Department of Fair Employment and Housing (DFEH), which offers materials in multiple languages.
- Possibly coordinate cultural awareness training between ALRB and DFEH.
- ALRB is establishing formal relationships with other state agencies, so that farmworkers can go to one place for help; cross-agency referrals about where to get help with each issue.
