**ORDER TO SHOW CAUSE**

On August 26, 2022, the General Counsel of the Agricultural Labor Relations Board (Board) filed a request for subpoena enforcement in this matter. The General Counsel requests the Board authorize the filing of a superior court action pursuant to Labor Code section 1151, subdivision (b), and Board regulations 20217, subdivision (g), and 20250, subdivision (k) to enforce five subpoenas ad testificandum and one subpoena duces tecum served on charged party St. Supéry, Inc. dba St. Supéry Vineyards & Winery (St. Supéry).<sup>1</sup> The General Counsel alleges St. Supéry did not file any petition to revoke its subpoenas and otherwise has failed to respond to or comply with the subpoenas. The Board hereby ORDERS St. Supéry to show cause why the General Counsel’s request should not be granted. St. Supéry’s response must be received
