ALRB PUBLIC MEETING LITIGATION REPORT

This report discusses updates and developments that have occurred in litigation matters involving the Board since its December 1, 2022 meeting.

Petitions for Writ of Review of Unfair Labor Practice Decisions

California Appellate Courts

► Cinagro Farms, Inc. v. ALRB, Second District Court of Appeal, <u>Case No.</u> <u>B322632</u>

Summary: Petition for writ of review of the Board's decision in 48 ALRB No. 2, in which the Board found respondent Cinagro Farms, Inc. unlawfully misclassified a crew of workers and terminated them in retaliation for their protected complaints regarding the form of their paychecks and paystubs. In addition, the Board assessed civil penalties against Cinagro pursuant to Labor Code section 226.8 for willfully misclassifying the workers.

Status: Cinagro filed a petition for writ of review on August 24, 2022. The Board filed the certified record on September 1. Cinagro filed its opening brief on October 4. The Board filed its respondent's brief on November 7. Cinagro filed its reply brief on December 2. On December 16, the California Department of Industrial Relations filed an application for leave to file an amicus brief in support of the Board, which the court granted on December 21. The deadline for Cinagro to file a response to the amicus brief was January 10. Cinagro did not file a response. The matter now is pending issuance of an order dismissing the petition or granting the writ of review.
