Please take notice that the Agricultural Labor Relations Board (ALRB or Board) will hold a public meeting on Wednesday, July 26, 2023, at 10:00 a.m. at Hearing Room 72.167 in the Capitol Area East End Complex, 1500 Capitol Avenue, Sacramento, CA 95814 and the Public Employment Relations Board Los Angeles Regional Office at 425 W Broadway, Suite 400, Glendale, CA 91204.
