Please take notice that the Agricultural Labor Relations Board (ALRB or Board) will hold a public meeting on Wednesday, October 4, 2023, at 10:00 a.m. at Hearing Room 72.167 in the Capitol Area East End Complex, 1500 Capitol Avenue, Sacramento, CA 95814. Per California Department of Public Health guidance, masks are no longer required indoors, but should be worn around others who have respiratory symptoms, exposed to someone with COVID-19, or at higher risk for getting very sick.
