Please take notice that the Agricultural Labor Relations Board (ALRB or Board) will hold a public meeting on Wednesday, July 31, 2024, at 10:00 a.m. at ALRB Hearing and Conference Room, 1325 J Street, Suite 1900, Sacramento, CA 95814.
