- 1. Call to Order
 - Chair Hassid called the meeting to order at 10:10 A.M.
 - Board Members Present: Chair Hassid, Board Member Broad, Board Member Flores, and Board Member Lightstone.
- 2. Approval of Minutes from Public Board Meeting, December 11, 2024.
 - Board Member Broad moved to approve the minutes from the Public Board Meeting from December 11, 2024.
 - Board Member Flores seconded the motion.
 - Motion approved unanimously.
- 3. Board Chair's Report
 - No report provided.
- 4. Executive Officer's Report on Elections, Unfair Labor Practice Complaints, and Hearings Presented by Santiago Avila-Gomez
 - Santiago provided updates on Nagatoshi Farm, Inc.; Case 2023-CE-050-SAL, which has been settled. This case will be removed from the hearing calendar.

- 5. Litigation Report Presented by Laura Heyck
 - Chief Board Counsel Laura Heyck provided an update on the following cases:
 - BCV-24-101649 Wonderful Nurseries LLC v. ALRB et al.
 - A case management conference (CMC) is scheduled for February 20, 2024. The parties met on February 13 and agreed there is no opposition to continuing the CMC.
 - F088632/F088639 ALRB v. Superior Court of Kern County
 - The ALRB's and UFW's petitions for a mandate challenge the Superior Court's denial of the ALRB's demurrer to the complaint, filed in Kern County. The case is fully briefed as of December 2024.
 - F088515/F088520 (consolidated) Wonderful Nurseries, LLC v. ALRB
 - Opening briefs on appeal were filed by the Board and UFW on February 7, 2025. Wonderful's answering brief is due by March 10, 2025, with reply briefs due 20 days later.
 - Wonderful Nurseries LLC v. ALRB, Case No. 1:24-CV-01601-CDB
 - On December 30, 2024, a lawsuit was filed against the Board in the U.S. District Court for the Eastern District of California, challenging the Board's enforcement of the MMC process on constitutional grounds. The complaint seeks a declaration that the MMC statute is unconstitutional and requests injunctive relief.
 - On January 22, 2025, UFW filed a Motion for Leave to Intervene, with a hearing scheduled for March 3, 2025.
 - On February 3, 2025, Wonderful employees, represented by the National Right to Work Legal Defense Foundation, filed a motion to intervene. The Board opposed this motion on February 18, 2025 with a hearing set for March 17, 2025.
 - Wonderful filed a motion for a preliminary injunction on February 10, 2025, and the Board's opposition is due February 24, 2025. The hearing on the preliminary injunction motion is scheduled for March 17, 2025.
 - The court extended the deadline for the Board's response to the complaint to April 1, 2025.

- Rasha provided updates on the following:
- Two budget change proposals are currently before the legislature.
- One proposal requests funding for the relocation of a Sacramento office to a new labor agency building.
- The second proposal addresses anticipated workbook costs and includes funding for new positions and associated costs.
- A budget hearing is anticipated in March.
- Seven job positions are currently open and are posted online.
- 8. Legislative Report

 - The regulatory package is expected to be reviewed in 3 working days, with the review period ending by Tuesday, the 25th. Awaiting confirmation, and any changes will be updated.




